


HEALTH, SAFETY & ENVIRONMENTAL (HSE) POLICY



HEALTH SAFETY AND ENVIRONMENTAL POLICY:

- We have a responsibility to protect the environment and preserve the health safety of our employees. An important first step in realizing this responsibility is the adoption and communication of a meaningful Health, Safety and Environment (HSE) policy.
- In this document we set out in full our HSE policy and the associated commitments. The policy provides a framework for discharging our responsibilities by outlining the key HSE issue for M/s Hasnaat & Brothers Construction Company. We have also developed a set of commitments that provides details of the actions we intend to take.
- We are committed to implementing this policy throughout M/s Hasnaat & Brothers Construction Company. We hope that this publication has made clear for our employees what our aims are and how we intend to achieve them.

- Be a responsible corporate member of society committed to continuous improvement in HSE.
- Provide a healthy and safe work environment for employees
- Optimize use of natural resources and minimize environmental impact
- Ensure HSE considerations are integrated into all activities
- Develop a culture which encourages employees to take personal responsibility for HSE
- Aim to eliminate all incidents and injuries
- This policy has been adopted by all the employees and activities. Compliance with this policy is mandatory.

Actions

- Assess the workplace hazard and risk from our activities
- Use and maintain appropriate control measures to minimize these risks to employees
- Identify the scale and nature of potential emergencies and put in place formal plans to manage them
- Develop train and routinely validate staff for their HSE duties
- Monitor the health and safety performance of employees

- Employees see that HSE considerations are taken seriously by management
- The business is prepared for managing emergencies and incidents in a competent manner
- Working conditions do not have an adverse effect on the health and safety of employees

Actions:-

- Take social, environmental and economic considerations into account when making business decisions

- Overall HSE performance
- Future HSE priorities for business

- Conduct a strategic review of HSE needs, performance requirements and overall risk
- Establish and maintain an HSE management system including a HSE policy based on local legislation and M/s Hasnaat & Brothers Construction Company requirements
- Ensure management units regularly review and report upon their local risk profile, performance and compliance with legal and company requirements and maintain HSE records.

- Consistent standards of HSE management apply throughout M/s Hasnaat & Brothers Construction Company
- External authorities can readily understand the approach and assess its HSE performance

M/S HASNAAT & BROTHERS CONSTRUCTION COMPANY WILL AIM TO ELIMINATE ALL INCIDENTS AND INJURIES

Actions:-

- Ensure managers have a comprehensive understanding of current incident and injury performance in their area of responsibility
- Investigations all injuries, incidents, cases of occupational illness and any complaints from regulatory authorities or members of public
- Undertake all necessary risk assessments and act upon deficiencies identified
- Create improvement plans to reduce incidents and injuries and review annually

- Incidents and injuries are seen as avoidable
- Opportunities to improve are clearly identified
- Performance is measured and transparent
- The reduction in number of incidents and injuries is continuous

AND OPTIMIZE NATURAL RESOURCES USE

Actions:-

- Develop control mechanism that ensure an ongoing response to risk
- Prevent the generation of waste or if not possible, reduce, re-used and recycle
- Assess the benefits, environment fate and risk of potential products
- Optimize the use of natural resources across all activities and products
- Use approved assessment tools and techniques to create risk profile for new and existing assets

- The awareness of risk is a part of our culture
- Resources and management attention are focused on the most significant risks and opportunities
- Waste and emissions are managed responsibly to reduce the burden on natural resources
- The business is able to ensure that its HSE obligations to third parties are not compromised
- The risk of business interruption is reduced to the practicable minimum

- Employees are involved in incident investigations and the development of improvement plans

- Employees accept personal responsibility for their own health and safety
